## Policy for Proceeding with disciplinary action

- Notice shall be served to the accused, with evidence of breach of code of conduct when applicable.
  - 2. The accused shall be provided an opportunity to respond in writing against the allegations with any evidence to support his / her claims.
  - The accused shall be provided with an opportunity of personal hearing by the committee.
  - 4. The decision of the committee shall be communicated in writing.
  - 5. There shall be an opportunity for appeal against decision to the Principal that can be availed once. (appeal process attached as Anx 'A')
  - 6. Decision on appeal by the Principal shall be final.

## STUDENT APPEAL PROCESS AGAINST DISCIPLINARY ACTION

## Appeal and Review

The accused who has been awarded any penalty by the disciplinary committee may prefer and apply for appeal or review to the Principal / Chief Executive

- 1. An appeal or review shall be made in the form of a petition and in writing. .
- 2. The appeal shall be filed with the authority who passed the original orders
- 3. The appeal/review petition shall be made within Seven days from promulgation of punishment awarded
- 4. The petition shall set forth concisely the ground of objection to the punishment awarded in a proper and template language (shall not contain dis-respectful or obscene language).
- 5. The accused at no stage of the proceedings shall be represented by an advocate / counsel.

6. The decision of the Authority shall be final and could not be challenged in any court of law.
